For admissions purposes, the highest attempt will be considered. <ul> <li>Lee College testing center dates fill up quickly. Please register early and/or seek other locations for HESI testing.</li> </ul>
All prior and current transcripts must be submitted to the college prior to submitting the application. Applicants are entirely responsible for ensuring transcripts have been received in the Admissions Office. Any applicant who has previously attended a nursing program must provide a letter from the program director stating the student is in good standing with the program.
Begin the process of receiving the mandatory titers and vaccines. (See page 3) Some vaccine series take months to complete. It is strongly suggested that you begin this process early. <b>DO NOT SUBMIT ANY HEALTH DOCUMENTATION TO THE NURSING OFFICE.</b> You will receive instructions for submitting proof of vaccinations during nursing orientation.
LVN Program Applicants with CNA certification who wish to obtain credit for VNSG 1423 are responsible for submitting the completed Lee College Cross Credit Healthcare Request Form (pg. 9 of application packet) with application documents.
Applicants are responsible for submitting ALL application materials by deadline.

### **ADMISSION INFORMATION**

Admission is two-step and competitive. Admission to the college is step one, followed by application to the nursing program. Completed applications are reviewed and selection is based on a point system which ranks academic ability through prerequisite course grades and HESI readiness assessment. After all applicants are scored, selected applicants are invited to complete admission to the nursing program.

Full admission is not complete until <u>all</u> program admission requirements (including health requirements, satisfactory FBI Criminal Background Check, urine drug screen, and Texas Board of Nursing clearance) are completed on time. All required documents MUST be submitted and approved by the designated deadline (Fall admission – August 1; Spring admission – December 1; Summer admission – May 1. If items are not received prior to the deadline, the student will be unable to register for class and will therefore not be eligible to continue in the program. **Directions will be provided during the Lee College Nursing Programs New Student Orientation.** 

#### MANDATORY HEALTH DOCUMENTATION

- 1. Applicants must complete a criminal background check and urine drug screen. Any positive or flagged result will be reviewed and may disqualify the applicant from admission to the program.
- 2. It is required that students obtain and maintain personal health insurance while in the program. Acceptable personal health insurance must meet Minimum Essential Coverage (MEC).
- 3. Immunizations must be current and include:
  - Tdap (within 10 years), must have the pertussis component
  - MMR vaccination series (2 vaccines)
  - Varicella vaccination series (2 vaccines)
  - Annual flu vaccine (administered during flu season)
  - Hepatitis B titer showing immunity
    - If titer is negative, non-reactive, or not immune:
      - Submit proof of a 3-shot series dated after the negative titer
      - Submit repeat titer showing immunity dated after the 3-shot series
  - Annual negative Tuberculin Skin Test (PPD) or chest x-ray or negative QuantiFERON-TB Gold
  - ALL IMMUNIZATION RECORDS AND TITERS MUST INCLUDE FULL NAME AND DATE OF BIRTH.
- 4. Current BLS CPR (MUST BE American Heart Association Basic Life Support for Healthcare Providers). Other providers such as Red Cross are NOT accepted.

#### TSI REQUIREMENTS

College readiness in all areas (reading, writing, and math) is required for admissions into any Lee College Nursing Program. This requirement can be met in a number of ways. Please contact a Lee College advisor to find out if you are college ready in all areas.

### TRANSFER STUDENTS

Because of differences in program curricula, Lee College Nursing does not accept transfer nursing credits. Students who have previously attended another nursing program must apply to the program, meet admission requirements, and follow the program curriculum as written.

#### **ENTRANCE TESTING**

Lee College Testing Center offers admissions exam testing for all programs (see link on page 1 of packet). For LVN and ADN Program applicants, previous HESI A2 scores from other institutions will be accepted if they meet the following criteria: (1) scores must be within the last year; (2) must include all Lee College required components. For LVN-ADN Transition applicants, the HESI Fundamentals exam must be taken at Lee College Testing Center.



### **ELIGIBILITY QUESTIONS**

The following questions will be asked by the Texas Board of Nursing in order to determine eligibility for taking the NCLEX-PN or NCLEX-RN Examinations. If you can answer YES to any of the following questions, you will be required to complete the Declaratory Order process through the Texas Board of Nursing. This information is provided to make applicants aware of real or potential eligibility issues affecting licensure after completing the nursing program. The Texas Board of Nursing provides extensive public information about eligibility and appeal of eligibility for licensure. The board has a published appeal process that may require as long as 18 months to complete. A prior condition, problem, legal issue, health issue, or other specific incident or occurrence may NOT affect eligibility. Failure to proactively enter the declaratory board order process will delay or prohibit eligibility status. The Declaratory Order Form is available on the TBON website.

All applicants undergo an FBI criminal background check, including fingerprints.

- 1) For any criminal offense, including those pending appeal, have you:
- A. Been convicted of a misdemeanor?
- B. Been convicted of a felony?
- C. Pled nolo contendere, no contest, or guilty?
- D. Received deferred adjudication?
- E. Been placed on community supervision or court-ordered probation, whether or not adjudicated guilty?
- F. Been sentenced to serve jail or prison time or court-ordered confinement?
- G. Been granted pre-trial diversion?
- H. Been arrested or have any pending criminal charges?
- I. Been cited or charged with any violation of the law?
- J. Been subject of a court-martial; Article 15 violation; or received any form of military judgment, punishment, or action? (You may only exclude Class C misdemeanor traffic violations.)

**NOTE: Expunged and Sealed Offenses:** While expunged or sealed offenses, arrests, tickets, or citations need not be disclosed it is your responsibility to ensure the offense, arrest, ticket or citation has, in fact, been expunged or sealed. It is recommended you submit a copy of the Court Order expunging or sealing the record in question to our office with your application. Failure to reveal an offense, arrest, ticket or citation that is not in fact expunged or sealed, will at a minimum, subject your license to a disciplinary fine. Non-disclosure of relevant offenses raises questions related to truthfulness and character of the Nurse.

**NOTE: Orders of Non-Disclosure:** Pursuant to Tex. Gov't Code 552.142(b), if you have criminal matters that are the subject of an order of non-disclosure you are not required to reveal those criminal matters on this form. However, a criminal matter that is subject of an order of non-disclosure may become a character and fitness issue. Pursuant to other sections of Gov't Dose chapter 411, the Texas Board of Nursing entitled to access criminal history record information that is the subject of an order of non-disclosure. If the Board discovers a criminal matter that is the subject of an order of non-disclosure, even if you properly did not reveal that matter, the Board may require you to provide information about that criminal matter.

- 2) Are you currently the target or subject of a grand jury or governmental agency investigation?
- 3) Has any licensing authority refused to issue you a license or ever revoked, annulled, cancelled, accepted surrender of, suspended, placed on probation, refused to renew a professional license, certificate or multi-state privilege held by you now or previously, or ever fined, censured, reprimanded or otherwise disciplined you?
  - \*4) Within the past five (5) years have you been addicted or treated for the use of alcohol or any other drug?
  - \*5) In the past five (5) years have you been diagnosed with, treated, or hospitalized for schizophrenia and/or psychotic bipolar disorder, paranoid personality disorder, antisocial personality disorder, or borderline personality disorder which impaired or does impair your behavior, judgement, or ability to function in school or work? (You may answer "No" if you have completed and/or are in compliance with TPAPN for mental illness OR you've previously disclosed to the Texas Board of Nursing and have remained compliant with your treatment regime and have no further hospitalization since disclosure.)
  - \*Pursuant to the Occupations Code 301.207, information, including diagnosis and treatment, regarding and individual's physical or mental condition, intemperate use of drugs or alcohol, or chemical dependency and information regarding an individual's criminal history is confidential to the same extent that information collected as part of an investigation is confidential under the Occupations Code 301.466.
