**WHEREAS**, on the 13<sup>th</sup> day of February 2023, the Lee College Board of Regents ordered the Lee College District General Election to be held on May 6, 2023, to fill three expiring terms of office; and

**WHEREAS**, the Vice President of Finance and Administration for the Lee College District, the authority responsible for having the official ballot prepared, has certified in writing that no person has made a declaration of write-in candidacy under applicable law and that each candidate on the ballot for the May 6, 2023, Election is unopposed for election to office; and

**WHEREAS**, the Vice President of Finance and Administration for the Lee College District, has delivered to the Board of Regents of the Lee College District Certification of Unopposed Candidates, which certification is attached hereto as Exhibit "A;" and

**WHEREAS**, in accordance with Section 2.053(a) of the Texas Election Code, the Board of Regents declares the unopposed candidates elected to office and cancels the May 6, 2023, Election.

**THEREFORE, BE IT ORDERED BY THE LEE COLLEGE DISTRICT BOARD OF REGENTS:**

**THAT** the Lee College District Board of Regents declares the following candidates, who are unopposed in the May 6, 2023, Election, elected to office and said candidates shall be issued certificates of election following the time the election would have been canvassed:
